ASSESSOR MONTHLY REPORT November 2018

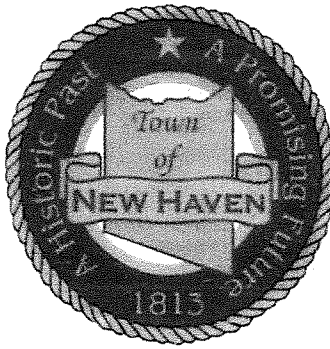


