

## **NEW HAVEN TOWN BOARD MEETING HELD DECEMBER 16, 2025**

### **CALL TO ORDER**

Supervisor Dan Barney called the monthly meeting for December 16, 2025 to order at 6:00 p.m. at the New Haven Town Hall. Roll call: Council Member; Mary Curcio (at the start of roll call, Mary Curcio was absent but arrived at 6:02 p.m.), Council Member; Patricia Prosser, Council Member; Joe Spereno, Council Member; Fred Wilbur (absent), and Supervisor; Dan Barney present. Also present: Town Attorney; Carl Schmidt, Deputy Town Clerk; Cindi Giovo, Highway Superintendent; Robert Parkhurst, and a few members of the public.

**Host Community Agreement w/US Light Energy:** Project Developer, Alex Burnett and Stephen Almy from the firm of Barclay & Damon were present. Alex Burnett spoke on the collaboration with their counsel, New Haven Planning Board, Town Attorney, Carl Schmidt and New Haven Town Supervisor, Dan Barney to establish a Host Community Benefit Agreement totaling \$50,000. The Host Community Benefit is an extra payment that is specific for the Town of New Haven. This Host Community Agreement will likely be required as condition of approval by the New Haven Planning Board on Wednesday, December 17.

**Attorney Fees Addendum:** Motion by Joe Spereno, second by Mary Curcio, to approve the attached addendum agreement for the payment of municipal consultant services, by prior resolution on September 16, 2025, pursuant to Article 6 of the New Haven Solar Law; the Town Board establishing a fee schedule to recover the Town's expenses and set the applicable fee at the existing contract for the Town Attorney.
